CVUSD receives updates to Board Policies and Administrative Regulations five times a year from GAMUT. GAMUT is a policy update service offered through the California School Boards Association (CSBA) which provides information about new laws and court opinions which may affect Board Policies and Administrative Regulations, and Board Bylaws.

These policy and administrative regulation amendments clarify (1) that the policy is applicable to off-campus conduct that may have a continuing impact on a student at school, and (2) that the district must investigate all allegations of discrimination of which it has notice, regardless of whether a formal written complaint is filed, and must take action to address any effect of discrimination found. Board Policy 3555 is mandated for any district whose child nutrition programs (i.e., National School Lunch Program, School Breakfast Program, and/or other child nutrition program) receive state or federal funding. 5 CCR 4621 mandates that districts adopt uniform complaint procedures for the investigation and resolution of specified types of complaints, and 5 CCR 4610 makes those procedures applicable to allegations of unlawful discrimination, harassment, intimidation, bullying, or violation of state or federal laws governing educational programs, including child nutrition programs.

A meeting was held with the Parent on October 26, 2016 to discuss the recommendation and interim education alternatives. A Stipulated Agreement was entered into with the Parent and Student.

ISSUE:

Should the Board of Education determine whether to continue with Nathan Harimoto as a Personnel Commissioner or make a new appointment to the Personnel Commission for the term of office commencing December 1, 2016, through November 30, 2019?

BACKGROUND:

In accord with Education Code 45240, the Board of Education must appoint or reappoint a candidate to serve on the Personnel Commission upon a vacancy. The appointment of the Board-appointed Commissioner is for a three (3) year term. Mr. Nathan K. Harimoto has served as the Board appointee on the Personnel Commission since 1991, with his current term expiring on November 30, 2016. Mr. Harimoto has upheld the principles of the merit system in a fair and consistent manner.

The California Education Code requires that the governing board make a public announcement of the name of the nominee at a regular Board of Education meeting. A Public Hearing is then required not sooner than thirty (30) days nor more than forty-five (45) days from the date of the announcement. The purpose of the Public Hearing shall provide the public, employees, and employee organizations the opportunity to express their view on the qualifications of the person recommended for the appointment. After the Public Hearing, the Board of Education shall appoint the nominee or make a substitute appointment without further notification or Public Hearing.

In accord with Education Code 45246 (g) a commissioner whose term has expired may continue to discharge the duties of the office until a successor is appointed, but for no more than 90 calendar days.
